I. COVID INFORMATION

II. COURSE INFORMATION

A. COURSE DESCRIPTION

Personal and family accounts, budgets and budgetary control, bank accounts, charge accounts, borrowing, investing, insurance, standards of living, renting or home ownership, and wills and trust plans.

B. PREREQUISITE: None.

- D. **CORE CURRICULUM:** This course partially satisfies the Core Curriculum Requirement for Social and Behavioral Science Foundational Component Area (080).
- E. **CORE CURRICULUM OBJECTIVES ADDRESSED:**
Communications skills—to include effective written, oral and visual communication
Critical thinking skills—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information
Empirical and quantitative competency skills—to manipulate and analyze numerical data or observable facts resulting in informed conclusions
Personal Responsibility—to include the ability to connect choices, actions, and consequences to ethical decision-making.
Social Responsibility—to include the demonstrated knowledge and competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
- F. **STUDENT LEARNING OUTCOMES:**
1. Identify the concepts associated with the time value of money.
2. Identify the differences among various savings and investment programs and classes of securities.
3. Identify the options for insurance
4. Describe retirement and estate planning techniques.
5. Explain the benefits of owning versus renting real property.
6. Discuss consumer protection legislation.
- G. **STUDENT LEARNING OUTCOMES ASSESSMENT:** This will vary and is geared towards TaskStream and WECM standards. This course will be assessed on an annual basis.
- H. **ATTENDANCE POLICY:** Attendance is required for this course. It is scheduled to meet two times per week and roll will be taken by the instructor at every schedule class period.

This is a class in which student attendance is required. If a student stops attending class, they WILL BE DROPPED and receive a grade of "X" after SIX unexcused absences EVEN IF they continue to complete assignments.

Any student not present at roll taking will be marked absent unless prior arrangements have been made. Class will begin PROMPTLY at the scheduled time.

The Blackboard software used to manage this online course tracks student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important in order to meet the objectives of this course. You will feel more at ease with the materials if you stay in touch with what is going on. This course is 3 semester credit hours. For this reason, you should set aside a minimum of 6 hours per week to work on this course. One of the very first things you should do is set aside time each week to work on the class. It is very easy to put off attendance in an online course.
