COURSE DESCRIPTION

This course is a study of Pediatrics which is a study of childhood diseases, and childcare from infancy through adolescence. Pediatrics will focus on the care of the well and the ill child utilizing the nursing process.

STUDENT LEARNING OUTCOMES

At the completion of the semester students will:
1. Identify the different structures in pediatric patients versus adult patients
2. Be able to describe various childhood diseases
3. Be able to discuss the normal homeostasis of a pediatric patient and be able to recognize changes in this state

ADDITIONAL CLASSROOM ITEMS

Students should come to class prepared with pens, pencils, and a spiral notebook for taking notes or completed quizzes or assignments in class. Students should be prepared to take notes over lecture material if they choose. You may use your computer for this course content only in the classroom. Follow student conduct guidelines for appropriate use of electronics in the classroom. Due to COVID we may have to meet virtually at some point. Please have a plan prepared as to how to meet via computer for this course. **You will need to have access to a computer and it will need to have a camera and a microphone.** When we meet virtually it will be Microsoft Teams, Blackboard Collaborate or Zoom. In the event that we must meet in the virtual setting please notify me if you do not have a computer to use.

ATTENDANCE POLICY (*READ CAREFULLY)

Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

Roll is taken for each class by signature page; it may be taken several times during a class period. A student who is not present when roll is taken is “absent.” A student is not allowed to disrupt the class for tardiness. A student who is late may come into the classroom after a break to hear the lecture, BUT the student will still be marked as “absent.” Learning is fostered in the classroom environment. Missing even one lecture/class activity can negatively impact student performance; therefore, classroom attendance is mandatory and students are accountable to attend and be on time for class.

Students are expected to do all classwork at the time scheduled, whether the class is “live,” per pre-corded lecture or via Zoom—this means the students should be “in class” during this time, not working, driving, shopping or doing some other activity.

A student who exceeds more than 2 absences in this course will be withdrawn from the program with an “F”.

LIVE classroom: students must be in their seat ready for class at the scheduled time. Classes will be held on scheduled exam days with lectures to immediately follow the exam. Students who leave after the exam are counted as “absent.” Students who are late for the exam, will not be allowed to take the exam.

Roll may be taken at any time during the class. Anytime the student is not present, the student is counted as a full absence. Breaks are given during the lecture time. Because we must closely monitor student movement in

the building, you may only have a break when one is given. If you leave the classroom for any reason, you may not return and are counted absent. Students should use break times wisely—going to the bathroom, getting refreshment, etc. rather than spending time on cell phones and then wanting to go to the bathroom when class starts.

ZOOM classes/meetings: Zoom meetings are considered formal classes. Therefore, the student must be present in stationary environment—not working, driving, shopping or engaged in some other activity. There should be no TV, cell phones or other distractors during the meeting. **The student’s camera must be on for the entire time of the class/meeting.** The microphone should be muted unless the student is answering a question, presenting information, or otherwise engaged in the course discussion. **If the student does not follow zoom etiquette as outlined in the VN handbook, the student will be removed from the zoom meeting and given an absence. The student MUST BE ON TIME for the zoom meeting; once the course instructor has started the lecture/meeting, the late student WILL NOT be allowed in and will be counted as absent.**

Students must attend all live classroom presentations and all Zoom meetings. A student who exceeds the allowable absences in any one class will be withdrawn from the program except in the case of a Covid exposure (see handbook for policy).

COVID-19

1. SPC policy will recommended a 3-day isolation period for individuals that test positive.
 - a. Please note that day 0 is the date of positive test. Day 1 begins the first full day after the date of positive result.
2. COVID reporting
 - a. Please have students and employees notify DeEtte Edens if they have tested positive to verify dates before returning to class or work.
 - b. The home tests are sufficient but students need to submit a photo of the positive result. The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor’s note or email notification. Results may be emailed to DeEtte Edens, BSN, RN at dedens@southplainscollege.edu.
 - c. A student is clear to return to class without further assessment if they have completed:
3. The 3-day isolation period, symptoms have improved and they are afebrile for 24 hours without the use of fever-reducing medication.
4. Please instruct students and employees to communicate with DeEtte Edens prior to their return date if still symptomatic at the end of the 3-day isolation.

5. Exposed individuals will not be required to quarantine. If exposed, SPC does request individuals closely monitor themselves. If an individual does become symptomatic, please do not attend class or work and be tested.

Students should take an absence when they are truly ill (running fever, nausea/vomiting not due to pregnancy, diarrhea or some other communicable disease). A physician's release should be submitted when the student is treated by a physician

Students who attend class exposing classmates to disease will receive a 10 point deduction on the next (or current) examination!

Students who exceed the allowable absence no longer meet the course criteria and must withdraw.

Absences are recorded for the whole day if a class is scheduled for the whole day. If a student leaves before the end of the class period, the student is marked "absent" for the day. There are no "half-day" absences. If the student is asked to leave the classroom for any reason (sleeping, talking or other inappropriate behavior), the student is given an absence and the subsequent point deduction.

Attendance is most often taken by a sign in sheet. Students who "forget" to sign in are counted as absent.

As a matter of courtesy and professional behavior, a student who is going to be absent should email or call the course instructor and inform the instructor of the pending absence.

4.1-B Tardy: Tardiness is not accepted in the Vocational Nursing Program. Students are either present on time or they are absent.

4.1-C. ATTENDANCE RECORDS: Because the student is an adult learner, each student should keep his/her own record of absence. Faculty is under NO obligation to inform a student of absences; the student will be notified when he/she no longer meets program objectives because of excessive absences and the student is being withdrawn. Should the student believe a discrepancy exists, the student should submit the notice in writing to the Program Director within 24 hours of notification.

4.1-D. RELIGIOUS HOLY DAYS ABSENCES: In accordance with Section 51.911, Texas Education Code, SPC will allow a student who is absent from class for the observance of a religious holy day to take an examination or complete an assignment scheduled for that day within seven calendar days after the absence.

Students are required to file a written notification of absence with each instructor within the first fifteen (15) days of the beginning of the semester in which the absence will occur. Forms for this purpose are available in the office of the Director of Special Services along with instructions and procedures. "Religious holy days" means a holy day observed by a religion whose place of worship is exempt from property taxation under Section 11.20, Tax Code.

ASSIGNMENT POLICY

Assignments/Quizzes may be given as a "Ticket to Class" or to enhance learning of the course material. These activities will count toward 10% of the total course grade.

Students may be assigned ATI quizzes that will be completed outside of class time and have a time scheduled to complete them. You only have one attempt on these quizzes and the honor code is in place as this is not a group

assignment. ATI Quizzes will be **due before 8 am on the due date**. The quiz will be closed at 8 and will not accept any late work.

Tickets to class may include: Chapter outline, lecture outline, ATI quizzes, ATI Active Learning Templates, Ah Ha! Points, Muddiest points. Tickets to class shall be communicated via Blackboard Announcements.

Submitting work: Follow assignment instructions.

All required work must be in on time in order that the student may benefit from the corrections and study for future examinations. Assigned outside work is due on the dates specified by the instructor. No late work is accepted. All work is submitted via ATI or Blackboard.

Students should retain a photocopy or computer-accessible file of all assignments turned in. Always have a backup copy. All work is submitted via ATI or in the Blackboard classroom.

Assignments are not accepted by email. You must submit via ATI or via Blackboard depending upon the assignment **and it is your responsibility** to make sure that you do not upload blank documents and that your document **can be opened on a PC, because not all Mac files are able to convert**. If you submit a blank document or a file that cannot be opened, it will not be accepted, unless informing instructor a minimum of **two hours** prior to deadline. If within this timeframe, instructor can clear the previous attempt and allow student to resubmit before the deadline. Again, it is your responsibility to make sure it is compatible and not blank.

COMPUTER USAGE

As computer technology in the field of health occupations continues to become more popular, computers will be used in this course. All students must have access to computers, web cam, microphones and printers. Some may be available on the South Plains College campus. Students will be expected to utilize computers to access assignments, classroom resources, Zoom Meetings and possibly exams. All registered students are supplied with a working email account from South Plains College. The use of TikTok is prohibited on SPC devices and WiFi. TikTok may not be used for online assignments.

ALL STUDENTS ARE EXPECTED TO KNOW THEIR SPC STUDENT USERNAME AND PASSWORD.

COMPUTER LAB USAGE

The computer lab in building 8 may be used by students during scheduled open hours or as assigned by an instructor. Printer paper will not be provided for students to print materials but students may seek assistance from faculty or staff to request lab paper from the college if needed. Lack of computer lab paper is not an excuse for not having homework assignments, skills lab sheets, or any other required documents. Students should come prepared for class.

EXAMS

- See Lecture/Exam Schedule.
 - Presentation of material includes class lectures, discussion, handouts, videos, and power point. Exams may be on paper with pencil or via computer by ATI.
 - Exams are administered in a campus computer lab using ATI and the lab must be reserved by the instructor in advance. Students are expected to arrive on time to exams and complete the exams within the time frame allowed as other classes may be booked behind our scheduled time and you will not be permitted to take your exam past the scheduled time unless arrangements are made in advance for

extenuating circumstances. Due to the ever changing COVID conditions it is possible that you may take exams on ATI and have it proctored by ATI Proctorio. **It is your responsibility to make sure that you have working computers with a web cam and a microphone and reliable internet.**

- In addition to course exams, each student will take a content mastery exam. Each student should score a Level 2 on each specialty exam. It is scored as follows: Level 3—95, Level 2—85, Level 1—70, less than Level 1—60.
- The Final Content Mastery exam may substitute the lowest exam grade pending the student has ZERO absences.
- The Content Mastery exams will be given as:
 - Practice Exam A/B
 - Pediatric Assessment
- The Pediatric Assessment will count 10% of the final grade.
- Grades will be recorded on Blackboard for the student to view. The student will also be provided a grade sheet on Blackboard for all grades to be recorded by the student after reviewing their exams. It is up to the student to keep up with their grade sheet and grades.
- Students will have the opportunity to review each exam taken as scheduled by the instructor. After viewing the exam, if the student has further questions, the student will need to email the instructor for an appointment to review the exam for further explanation. The student must discuss this with the instructor within 48 hours of viewing their grade. Once the 48 hours has passed without the student questioning the grade or question, **the assigned grade is final and may not be challenged at the end of the course. Grades will not be emailed or given out by phone.**
- Medical Terminology: Abbreviations & Definitions may be included in the unit exams.
- Assignments/ Quizzes/Quizzes may be given as a “Ticket to Class” or to enhance your learning of the course material and will count toward 10% of total course grade.
- Students must earn a “76” or better in this class and meet all criteria as discussed above for progression.

MISSED EXAMS/MAKEUP WORK:

Students are expected to take all examinations for each nursing course. There are NO makeup exams for this course. Since the final exam is comprehensive (meaning that it covers the entire course), the final exam grade will be substituted **FOR THE MISSED EXAM GRADE ONLY**. If any additional exams are missed, a grade of “0” will be recorded. There is no make-up exam for the Final Exam

NO exams will be given prior to the originally scheduled exam. Please do not ask.

Any action interpreted as cheating by facilitating instructor may result in immediate removal from the testing area, a zero recorded for the test grade and possible removal from SPC nursing program.

REMEDIATION

If the student fails the first exam in the course, the student is required to meet with Student Success Coach and/or Nursing Success Coordinator at least 3 days prior to the next exam. A First Exam Alert form will be sent by the instructor to the Student Success Coach (Mrs. Berryhill) and she will contact the student via email to set up an appointment to meet.

Content Mastery

Once a practice exam is completed, the student will then log into ATI and complete a Focused Review. Once the focused review is completed, the student will then retake the Practice Exam to improve the score. See class schedule for when focused reviews/remediation is due.

Course Exams

Any exam grade below an 80 will require a meeting with your instructor to be scheduled within 48 hours of the exam. Upon meeting with the instructor, an exam wrapper will need to be completed so the student and instructor can review together. Remediation for course unit exams will be assigned at the discretion of the instructor.

GROWTH AND DEVELOPMENT PRESENTATION

Objectives:

1. Supplement the student's knowledge concerning the growth and development of children
2. Supplement the student's knowledge concerning the physical requirements of children in specific age groups
3. Allow the student to research and articulate the behaviors and norms of children in a specific age group
4. Research motor and psychological skills commonly used by the specific age group thus allowing the student to choose toys and create games that would enable the pediatric client to demonstrate the utilization of these skills
5. Apply knowledge to relate teaching according to common children's theorist stages and phases
6. Provide the student an opportunity to practice teaching skills to peers, using a mixed media approach

Directions:

1. Each student will sign up for a specific age group thus becoming a member of a team
2. Each member of the team will be expected to participate in the project to earn full points (see grading rubric)
 - a. Each team member will receive the *same* grade, unless absent
 - b. If a student is absent on the day of presentation, they will receive a zero
 - c. Refer to: **Pediatric Project Rubric for grading reference**
3. A **HANDWRITTEN** rough draft will be due the day before the scheduled presentation.
 - a. Each member will submit their portion of the project in the rough draft.
 - b. If for any reason, a member of the group has not participated and the rough draft indicates this, that individual will be docked points according to the grading rubric.
4. Presentations should be from 5-10 minutes in length

5. ***Make it memorable*** so your peers will learn and recall your information. Strive to be the BEST team!
The class will secret-ballot vote for which team made the material easiest to understand AND remember. That is how “The BEST team” is decided.
6. Each team will be responsible for bringing at least **6 age-related items** (toys, games, snacks, etc.) to class on designated date
7. Each team will present to the class utilizing lecture, handouts, posters, or demonstrations (ask: Will my peers learn from this?)
 - a. **Psychosocial development:** (discuss language, socialization, & stages according to children theorists)
 - a. Plan **ONE** simple activity (games, crafts—please be creative) compatible for age group
 - b. **Show** at least **four** age specific toys (must support why these are appropriate for age)
 - b. **Physical development:** Discuss average growth and development of specific age group (height, weight, VS, etc) including major developmental tasks (fine and gross motor skills) for the age group (note what would constitute a delay)
 - a. Provide a nutritional snack appropriate for age group (hands on item)
 - c. Discuss appropriate nutritional requirements (including safety), sleep patterns and immunizations for age group
 - d. Note important safety considerations and injury prevention teaching pivotal to that age group
 - e. Discuss any unique considerations for hospitalization at that age based on knowledge of growth and development

STUDENT CONDUCT
